## **2010 Rider**

### **BILLING**

In all headline situations, Artist shall receive 100% headline billing in any and all publicity releases and paid advertisements, including but not limited to programs, fliers, signs, lobby boards and marquees. When not headlining, Artist shall always have Special Guest Star billing. Billing in all advertising and publicity is to read:

**Rusty Evans and Ring of Fire – A Tribute to Johnny Cash**

### **FORCE MAJEURE**

Artist's obligation to furnish the Entertainment unit referred to herein is subject to the detention or prevention by sickness, inability to perform, accident, means of transportation, Act of God, riots, strikes, labor difficulties, epidemics and/or order of any public authority or any cause, similar or dissimilar, beyond Artist's control.

Provided Artist is ready, willing and able to perform, Purchaser agrees to compensate Artist in accordance with the Terms hereof regardless of Act of God, fire, accident, riot, strike or any events of any kind or character whatsoever, whether similar or dissimilar to the forgoing events which would prevent or interfere with the presentation of the show hereunder.

### **INCLEMENT WEATHER**

Notwithstanding anything contained herein, inclement weather shall not be deemed to be a force majeure occurrence and the Purchaser shall remain liable for payment of the full contract price even if the performance(s) called for herein are prevented by such weather conditions. Artist shall have the sole right to determine in good faith whether any such weather conditions shall render the performance(s) impossible, hazardous or unsafe.

### **TAXES/DUES/FEES**

Purchaser shall pay and hold Artist harmless of and from any and all taxes, fees of any kind (including any and all Unions), dues of any kind and the like related to the engagement hereunder and the sums payable to Artist shall be free of such taxes, fees, dues and the like.

## **SOUND, LIGHTING AND STAGE PRODUCTION**

Purchaser shall furnish a sound and light system specifically designed to provide superior quality production. The fee for this shall be paid for by the Purchaser and is separate from Artist's compensation.

One follow spot, two if possible.

FOR ALL OUTSIDE PERFORMANCES ARTIST REQUIRES A ROOF OVER THE PERFORMANCE AREA. A TENT STRUCTURE IS ADAQUIT AS LONG AS IT IS SECURILY FASTENED AND OF A HIGH GRADE PROFESSIONAL QUALITY.

## **EQUIPMENT AND INSTRUMENT REQUIREMENTS**

One 8 x 8 x 2 drum riser with carpet at purchaser's sole expense.

Three (3) on stage guitar stands

# **Back line**

## **Bass Rig**

One (1) four string Fender Bass Guitar (to be used for back-up purposes only in case the airlines loose our luggage. )

One (1) SWR/AMPEG or other high quality bass cabinet with one 15-inch single speaker or two 12-inch speakers and one (1) 50 to 100 Watt head or Combo Amp is satisfactory.

## **Guitar Rig**

One (1) six String Fender/Yamaha or other high quality acoustic guitar (to be used for back-up purposes only in case the airlines loose our luggage)

One Fender Telecaster Guitar (to be used for back-up purposes only in case the airlines loose our luggage)

One (1) Fender de Ville or Twin Combo Amp

## Drum Kit

One 22" or 24" bass drum.

One DW 5000 kick pedal.

One 12" – 15" rack tom.

One 14" standard WOOD snare drum.

One 10" – 18" crash cymbal on an independent stand.

One 20" – 24" ride cymbal on a boom stand.

One 14" – 15" high hat with stand.

One standard round drum stool. Stool must be in "like new" condition.

One 8 x 8 x 2 drum riser with carpet.

### **OTHER PRODUCTION PROVISIONS**

DVD projection system with at least one, preferably two 9x12 rear projection screens and one operator. This is for the presentation of a pre-performance DVD slide show only and is not mandatory. Please let Steve Selak (818-842-5800 Work / 213-709-4909 Cell) know if the venue is able to provide this and I will forward the DVD.

Air travel provided by Purchaser shall consist of (5) Non-Stop Coach Class tickets. If Non-Stop tickets are not available please contact Artist's representative. Before airfare tickets are purchased on behalf of Rusty Evans and Ring of Fire ALL DEPARTING DATES AND TIMES MUST BE CONFIRMED AND APPROVED BY ARTIST IN ADVANCE OF PURCHASE.

Ground transportation requirements are as follows:

Arriving by plane:

One 12-passenger van with driver available at baggage claim or local ground transportation buy out of cost plus \$10%.

### **MERCHANDISE**

Artist shall have the sole and exclusive right, but not the obligation to sell souvenir programs, posters and all other merchandise directly pertaining to and/or bearing the likeness of the Artist thereof, including phonograph records, in connection with, and at the performance hereunder, and to retain 100% of the receipt therefrom, with the sole exception of any financial arrangements with the concessionaires for the handling and/or sale of this merchandise, nor shall the operator allow the sale and /or giving away of any items

(programs, posters, albums, etc.) of any other artist connected with this performance.

## **HOSPITALITY AND DRESSING ROOM**

Purchaser shall provide one dressing room for Artist's sole use and must be secure via a lock or security. These rooms should be capable of accommodating five (5) people and each should be equipped as follows:

-Clothing rack and hangers

-Comfortable chairs and couches

-**Private toilet facilities** to be used solely by Artist.

**-When performing in remote locations where no plumbing type toilet facilities are available then ONE PRIVATE "PORTA JOHN" WITH HAND WASHING FACILITIES FOR ARTIST SOLE USE MUST BE PROVIDED within 50 feet of performance area.**

-Mirrors

-110 V. AC power outlets

-FOR MULTIPLE PERFORMANCE DATES WE WILL NEED TO ACCESS A DRYCLEANER FOR EACH DAY WE PERFORM. PLEASE ADVISE ON HOW WE CAN BEST GET THIS ACCOMPLISHED.

## **CATERING**

Purchaser shall provide five (5) hot meals and this service should be available within a place that is open 24 hours a day. If 24 hour service is not available please advise. Food coupons for Fairs and Festivals are acceptable or a \$35 food buy out per person / day.

If meals are to be catered and served backstage then Purchaser shall provide five (5) hot meals. Dairy is permitted but we ask that you please limit its use. It tends to add discomfort while singing. Of these five hot entrees their must be:

One fish

One chicken

Three of either beef, chicken, pork or fish

Each meal shall consist of one appetizer, a fresh green salad with at least one non-dairy dressing (Italian, olive oil and vinegar), hot entrée, two vegetables, potato or bread and a desert. Dinner should be served directly following sound check. If the band is unable to eat prior to sound check then arraignments should be made for them to eat after the show.

**Dressing Room Catering:**

Two hours prior to Artist's performance, the large dressing room shall be stocked with the following food and drink at no charge to Artist:

A small assortment of diet and non-diet beverages including 7-UP, Coke, Ginger Ale, cranberry juice, purified or natural spring water and mineral water (Perrier, club soda).

1 small tray assorted fresh fruits

1 small tray assorted fresh meats (ham, turkey, roast beef) and vegetables, black olives and natural cheeses.

A small assortment of condiments including crackers, breads, potato chips, mustard, mayonnaise.

Plates, napkins, eating utensils and cups.

Coffee Service with regular, decaf, cream, sugar and cups suitable for hot beverages.

Hot tea and honey

**Stage Drinks:**

One case individual non-carbonated spring water bottles.

10 Large hand towels.

**CHOICE OF LAW/FORUM**

This Agreement shall be deemed made and entered into in the State of California and shall be governed by all of the laws of such State applicable to agreements wholly to be performed therein.
